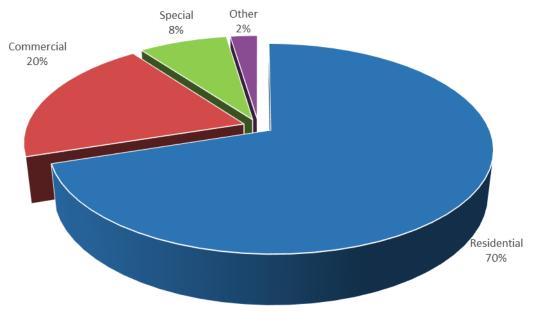

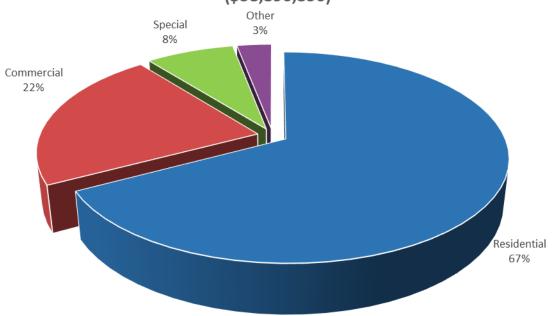




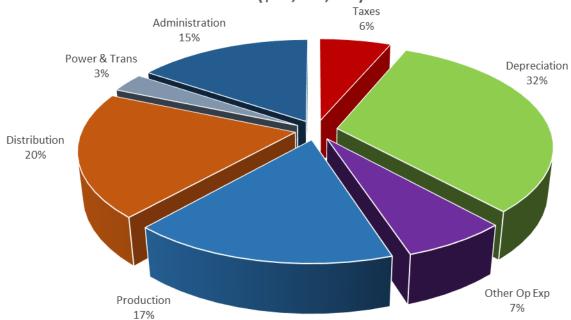
WATER SALES Year to Date - August 2020 (\$59,745,585)



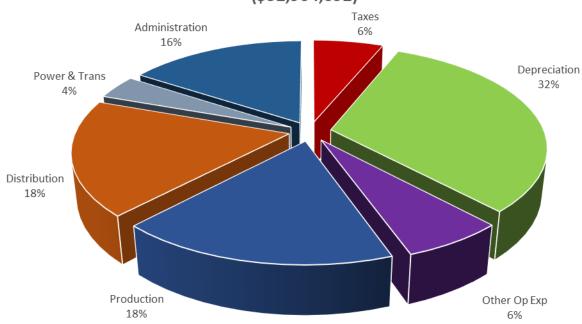
WATER SALES
