- D-1 Resolution U-10778 – Award contracts and approve purchases:
1. Award contracts to Weber Construction, Inc., and Stafford Excavating, LLC for the installation of three bridges (\$216,785 and \$90,620, respectively. Cumulative total \$307,405, including sales tax);
  2. Award contract to Pape and Sons Construction for the replacement of acquired asbestos cement water mains within the City of University Place (\$511,261.68, plus sales tax).

Upon Board request, Greg Volkhardt, Environmental Programs Manager, described the environmental benefits of the project on habitat for item number one.

Voice vote was taken and carried. The resolution was adopted.

D-2 Motion 15-05 - Amend Resolution No. U-10760 approved March 11, 2015, to direct that the contract term of any wholesale broadband service agreements to be negotiated by Tacoma Power and the Internet Service Providers not exceed two years in duration.

Mr. Patterson moved to postpone this motion to the Public Utility Board meeting of June 10, 2015; seconded by Mrs. Trudnowski.

Voice vote was taken and carried. The motion to postpone this item to June 10, 2015 was approved.
