Mar. 30	Required: Draft applications, due at 12 PM	Applicants submit draft application materials (see application checklist). Email to Tacoma Power staff. Application proposal presentations will be scheduled by Tacoma Power following receipt.
Mar. 31	Draft Applications distributed	Tacoma Power distributes draft applications to HAP subcommittee and FTC.
April 6 (week of*)	HAP Subcommittee Meeting**, review draft applications	HAP Subcommittee meets to review draft applications and begin preparing feedback.
