FTC Decision and Justification

The FTC supports the proposed workplan approach. The approval is given through online vote after discussion in the regular FTC meeting required a number of edits. The revised document was shared electronically with FTC members, including NMFS, Ecology, the Yakama Nation, WDFW, and Tacoma Power on May 4th and no additional requested revisions were received as of May 11th.

Proposed Decision or Consideration

The M&E subcommittee is seeking agreement and support from the FTC to follow the laid-out timelines and development of specified products of the Monitoring Plan. A proposed workplan to complete the Monitoring Plan for the submitted FHMP (October 2020) has been developed and shared with the FTC at the April meeting. This workplan has been vetted through the M&E subcommittee and edits were completed prior to walking the FTC through the document at the April 2021 meeting.

Background

The Monitoring Plan defines the steps and rough timeline to be followed to develop the supplemental document that describes the monitoring and evaluation efforts considered for baseline and directed studies. This decision document is seeking the approval of a proposed draft workplan.

The Monitoring Plan that will be developed by following the workplan is a supplement to the FHMP submitted to FERC in October of 2020. The Monitoring Plan will be revisited and updated on an annual basis as part of the APR process. The idea behind revisiting the document every year is that our knowledge will be growing and evolving each year, and investments in different baseline/directed studies may make more or less sense given our current state of knowledge.

The Monitoring Plan will be completed collaboratively through input by the M&E subcommittee as well as the FTC. The draft workplan lays out a timeline for feedback on several key elements for the document and leaves the potential for workshops on issues or topics that require further resolution. In addition, upon completion of the draft document, there will be a 30-day review window for the FTC and public to comment. Once revisions have been completed the plan will be made available to the FTC for review as a last step before finalization.
