Purpose



- 4. Tax Exemptions (13)
- Broadband and IT infrastructure (6)
- 6. Right to Work State (18)
- 7. Quality of life (2)
- 8. Energy costs (8)
- 9. Corporate tax rate (7)
- 10. Highway Accessibility (11)



2023 Electrical Services Accomplishments

- Advanced Meter C&I deployment complete
- Many large projects including 34 apartment buildings
 - 2024 has 16 new apt complexes to date
- 2,789 New Connections
- Accela permitting site launched mid-March



Electrical Services Focus for 2024

- Training new NS Engineers (5 of 7 total)
- New Service & Central Business District Engineering
 - Balancing materials and design
- Explore implementation of an Amp Fee (bring to PUB in 2025)
- Synchronizing permit and flat fee reviews with power rates
- Project deployments
 - Continue refinements to the Accela permitting platform
 - Version upgrade to Mobile Workforce Management

2023 Water New Services Accomplishments

- Improved Water Main Design timelines
 - Operational Improvements and Reduced # of Water Main Projects
- Cautiously optimistic about water service material inventory
 - Large water meters long lead times
 - No projects were delayed due to supply chain issues



 - Supporting SAP Upgrade efforts to improve Employee and Customer Experience



Tacoma Rail

2023 Accomplishments

- Rail grew its import automobile business by 1,200% over 2022 levels.
- Grants totaling \$16 million were secured to purchase 3 battery-electric locomotives and the charging structures to support them.
- Completed \$5 million upgrade to our locomotive servicing facility.

COVID -19 Impacts

• Supply chain issues have improved and lead times for procurement of track and locomotive parts have been realigned to the "new normal".

Number of customers and prospects assisted in 2023

- TPU interacts with customers and prospects in numerous ways.
- These interactions number in the hundreds and include efforts from
 - Economic Development
 - Account Executives
 - Business Solutions Office
 - New Services in Power and Water
 - Rail
 - Customer Energy Programs



Measurement 1 - Power

Number of customers and prospects assisted in 2023

- CoT Planning and Dev. Services plan reviews and comments = 444
- Issued Electrical Permits = 11,931
- Received and reviewed Electrical Service Applications = 558
- Executed Letters of Agreement for construction = 85



Measurement 1 - Water

Number of customers and prospects assisted in 2023

- Plan review and comments = 1,596 permits
- Provided construction estimates for new water services = 248
 - 130 Commercial // 76 Multifamily // 42 SFD developments

Private Contracts and main extension program in 2023

- 23 projects to Construction, 10.9 miles of new main
 - 5 Commercial // 18 Residential (Multi & SFD)
- 36 projects to the Design phase, 17+ miles proposed
 - 8 Commercial // 28 Residential (Multi & SFD)





Water Customer Experience has Qualitative feedback from the Development community.

- In 2023, in coordination with the Master Builders Association, we developed a list of concerns/suggestions that drives prioritization of improvement areas.
- Water participates with Tacoma Permit Advisory Group, listening to concerns/suggestions and reporting out on status/progress.
