# MINUTES City of Tacoma Public Utility Board Study Session October 11, 2023 3:00 p.m.

Chair Watson called the Public Utility Board study session to order at 3:00 p.m. in the third-floor conference room (LT1) of the Public Utilities Administration Building.

### **Cyber Security Training for the Board**

Rives Hassell-Corbiell, Cyber Security Awareness Program Manager, presented the Board with cybersecurity awareness training, a requirement for everyone with a city email address. Ms. Hassell-Corbiell, walked the Board through common targeted attacks, vulnerabilities, phishing, and best practices to mitigate attempts to bypass city systems. Training included how to identify false URLs and email address, and how to identify secure sites. The Director and Chair made positive remarks about this training.

### <u>Advanced Meter Infrastructure Project Update</u>

Sally Mohr, UTS Program Delivery Manager, and Corey Bedient, Technology Manager, presented the information. An overview of AMI, its strategy, milestones, and highlights were provided. The budget, deployment schedule history, and progress of meters deployed were detailed. Accomplishments in 2023 include: power commercial and industrial deployment being substantially complete, Water meter deployment is at 80 percent; stakeholder engagement maintained, and MDM upgrade. Looking forward, TPU will maintain its focus on the customer experience; adapt/maintain flexibility to supply chain uncertainty. The project remains within the target schedule and cost range. The presentation was concluded by summarizing AMI's operational benefits including grid modernization.

#### Legislative Agenda and Policies

Clark Mather, Community and Government Relations Manager, and Logan Bahr, State Relations Manager, presented this information. Staff is not recommending any changes to TPU's legislative policy document. The proposed federal and state legislative agendas for TPU and each of the operating divisions were detailed. The legislative

policy and agenda will be presented to a joint meeting of the City Council and Public Utility Board on November 7, 2023, and brought forth to the Board for consideration on November 15. Council consideration would follow.

## **General Board Comments/Discussion and Director's Reports**

Director Flowers reminded the Board of the budget and rates workshop scheduled for October 13.

The Board discussed the different options previously presented to them for Water rate adjustments in response to the closure of the WestRock mill.

#### **Closed Session**
