

Economic Development

Focus for 2023

- Continue focus on business retention and expansion efforts
- Provide our partners with support for recruitment opportunities
- Provide continued support for the COT's Green Economy Strategy as a member of the Green Economy Hub
- Monitor and identify trends that may require changes to our ED efforts
- Continued engagement with the land use planning process as needed
 - Tideflats Subarea Plan
 - South Tacoma Groundwater Protection District
 - South Tacoma Economic Green Zone



Constraints on Development

- The lack of land Rail owns on which rail-served facilities can be built. We depend on the Port/NWSA, private landowners or the Puyallup Tribe to provide land to developers which usually do not require rail service as their primary transportation option.
- Lack of right-sized industrial real estate
- Interest rates
- Ongoing supply chain concerns internal & external
- Power infrastructure capacity and industrial power limitations
- Workforce recruitment issues internal & external

2022 Electrical Services Accomplishments

- Many large projects including 35 apartment buildings
- 3,398 New Connections (Largest since 2007)
- Accela permitting site in development


Supply Impacts to Electrical Services

- Nation wide shortages of electric utility materials
- Pro-Active communications to customers
- Seeking material and design alternatives
- 2022 Customer connection revenue up 58% from 2021

- Synchronizing permit and flat fee reviews with power rates
- Customer Service Policy update (Complete)

 - C&I Advanced Meter Deployment (Near Completion)
 - Launch Accela Permitting platform (Sept 2023)

2022 Water New Services Accomplishments

- Supported continued strong levels of water main extensions
- Cautiously optimistic about water service material inventory
 - No projects were delayed due to supply chain issues


Challenges to Supporting Economic Development

2022 Accomplishments

 Rail aided the Northwest Seaport Alliance in attracting Hyundai's import auto business to Tacoma's Wallenius Wilhelmsen Auto loading facility from Portland.

COVID -19 Impacts

- Supply chain issues have delayed the procurement of track materials and locomotive wheels.
- All other functions are proceeding normally.

Measurement 1

Number of customers and prospects assisted in 2022

- TPU interacts with customers and prospects in numerous ways.
- These interactions number in the hundreds and include efforts from
 - Economic Development
 - Account Executives
 - Business Solutions Office
 - New Services in Power and Water
 - Rail
 - Conservation



Measurement 1 - Water

Number of customers and prospects assisted in 2022

- Plan review and comments = 1,329 permits
- Provided construction estimates for new water services = 360
 - 113 Commercial // 169 Multifamily // 78 SFD developments

Private Contracts and main extension program in 2022

- 31 projects to Construction, 13.2 miles of new main
 - 10 Commercial // 20 Residential (Multi & SFD) // 1 Church
- 37 projects to the Design phase, 17+ miles proposed
 - 10 Commercial // 26 Residential (Multi & SFD) // 1 School

Annually review New Service Engineering (Water and Power) and other relevant customer surveys.
