

RECOMMENDATION SUMMARY:

Tacoma Power (Power), Utility Technology Services and Advanced Metering requests approval to increase the Sensus Hardware SOW Contract 4600013747, to Sensus USA, Inc. (Sensus), Raleigh, NC, by \$3,000,000, plus applicable taxes, for additional hardware purchases for smart meters and maintenance and growth needs. This increase will bring the contract to a cumulative total of \$36,330,000, plus applicable taxes.

BACKGROUND:

The AMI Program consists of ordering and implementing an advanced metering infrastructure throughout the Tacoma Public Utilities' (TPU) service area with advanced meters for both Power and Tacoma Water (Water).


ISSUE: The current hardware SOW at \$33,330,000 is fully encumbered to secure all needed hardware for the AMI project. Additional hardware is now needed to support additional Power and Water AMI meters through 2024 to accommodate continued growth and maintenance within TPU's service territory. The AMI project was successful in securing quotes for the hardware at the existing 2018 AMI SOW prices, thereby avoiding significant inflation increases.

ALTERNATIVES: The City of Tacoma has committed to the Sensus Meters under the RFP PS18-0015F throughout the service area through 2024. Alternatives were not researched as Sensus committed to provide the meters under existing SOW pricing.

COMPETITIVE SOLICITATION: RFP Specification No. PS18-0015F was opened May 15, 2018. Seven companies were invited to bid in addition to normal advertising of the project. Seven submittals were received and thoroughly evaluated. A selection advisory committee (SAC) comprised of 10 members from Tacoma Power, Tacoma Water, Information Technology Department, and Customer Services ranked proposals using the following categories and weights: AMI Solution Requirements Compliance 40 percent; Price/Value - 25 percent; Network Coverage Plans 15 percent; Qualifications/Experience of Firm and Project Team - 10 percent; Proposed Methodology and Approach - five percent; and Small Business Enterprise (SBE)/Minority and Women's Business Enterprise (MWBE) - five percent. The proposal submitted by Sensus was ranked the highest by the SAC.

Sensus USA, Inc. submitted a bid that resulted in the lowest evaluated submittal. The table below reflects the amount of the base award.

CONTRACT HISTORY: This contract was originally awarded to Sensus USA, Inc. as a result of an RFP Specification No. PS18-0015F in March 2019. The contract term was set for five years. In June 2022, the contract was increased by \$330,000 utilizing the administrative authority granted by the Public Utility Board.

RECOMMENDATION SUMMARY:

Tacoma Water recommends a contract be awarded to Ceccanti Inc, Tacoma, WA, in the amount of \$8,933,025, plus a 15 percent contingency, for a cumulative contract total of \$10,272,978.75, plus applicable taxes, budgeted from the Tacoma Water System Development Fund, for the construction of a five-million-gallon, welded steel reservoir and installation of a City pre-purchased booster pump station.

STRATEGIC POLICY PRIORITY:

Assure outstanding stewardship of the natural and built environment.

BACKGROUND:

Tacoma Water's planned water system infrastructure, in the area just south of Bonney Lake known as Tehaleh, as part of the Environmental Impact Statement (EIS) and community master plan, was submitted from the developer (Cascadia) to Pierce County on August 28, 1998. The Pinnacle Ridge water storage tank (950 zone) and booster pump station (1010 zone) are the next planned water assets in the master plan.

ISSUE: The welded steel reservoir is needed to provide reliable water service to the rapidly growing Tehaleh community.

ALTERNATIVES: The alternative of not awarding a contract to Ceccanti Inc would be to re-bid. Delaying the project to re-bid would extend project completion and limit Tacoma Water's ability to serve customers in the higher elevation water zone of the Tehaleh community.

COMPETITIVE SOLICITATION: Request for Bids Specification No. TW22-0084F was opened August 2, 2022. Three companies were invited to bid in addition to normal advertising of the project. Three submittals were received.

Ceccanti Inc submitted a bid that resulted in the lowest evaluated submittal. The table below reflects the amount of the base award.

Paso Robles Tank Inc was deemed non-responsive for failure to list subcontractors pursuant to RCW 39.30.060.*

Pre-bid Estimate: \$8,900,000 The recommended award is one percent above the pre-bid estimate.

CONTRACT HISTORY: New contract.

SUSTAINABILITY: The equipment provided will meet environmental standards and product specifications. Life-cycle cost was considered in the original evaluation of alternatives for equipment and new assets to serve the Tehaleh area.

EQUITY IN CONTRACTING (EIC) COMPLIANCE: The recommended contractor is in compliance with the EIC requirements per memorandum dated August 4, 2022. The EIC requirements for this project are MBE two percent, WBE one percent and SBE two percent. The EIC utilization levels of the recommended contractor, Ceccanti Inc, are MBE 2.5 percent, WBE 1.01 percent, and SBE 3.5 percent.

LOCAL EMPLOYMENT AND APPRENTICESHIP TRAINING PROGRAM (LEAP) COMPLIANCE: The LEAP requirements for this project are 15 percent of the project labor hours must be worked by Local Employees and an additional 15 percent of the labor hours must be worked by Apprentices, per TMC 1.90.040.
