WHEREAS the City of Tacoma, Department of Public Utilities, requested bids or proposals for the purchase of certain materials, supplies, equipment or the furnishing of certain services, or proposes to purchase off an agreement previously competitively bid and entered into by another governmental entity or a purchasing cooperative, or for the sales of surplus, or desires to increase or extend an existing agreement, all as explained by the attached Exhibit "A," which by this reference is incorporated herein, and

WHEREAS in response thereto, bids or proposals (or prices from another governmental or cooperative agreement) were received, all as evidenced by Exhibit "A," and

WHEREAS the Board of Contracts and Awards or the requesting division have heretofore made their recommendations, which may include waiver of the formal competitive bid process because it was not practicable to follow said process, or because the purchase is from a single source, or there is an emergency that requires such waiver, or because a directly negotiated contract was determined to be in the best interest of the City, or waiver of minor deviations, and in the case of sale of surplus, a declaration of surplus has been made certifying that said items are no longer essential for continued effective utility service, as explained in Exhibit "A," Now, therefore,




BE IT RESOLVED BY THE PUBLIC UTILITY BOARD OF THE CITY OF TACOMA:

RECOMMENDATION SUMMARY: Tacoma Power, Utility Technology Services (UTS) recommends a contract be awarded to Motorola Solutions, Inc. (Motorola), Chicago, IL, in the amount of \$2,412,241, plus applicable taxes, budgeted from the Power Fund 4600, for an initial contract term of two years plus twelve years warranty and maintenance with the option to renew for additional annual maintenance periods, for a projected contract amount of \$4,100,559, plus applicable taxes, for P25 Conventional Radio Project for Cowlitz, Cushman and Nisqually Hydro Projects.

BACKGROUND:

Tacoma Power, UTS will be replacing the obsolete Land Mobile Radios for the Cushman. Cowlitz and Nisqually Hydro facilities. The estimated project duration is two years. Following acceptance of the work, there will be a one year of warranty, seven years of maintenance and twelve years of system support and upgrades. Motorola will install radios, network equipment and antennas on existing towers and communications buildings supplied by TPU.

ISSUE: TPU has disparate radio systems first implemented in the 1980s to support operations throughout its hydro project service areas. The systems' manufacturer considers the current equipment "end-of-life" and no longer provides replacement parts, service or support. TPU needs to replace the existing radio systems to meet operational business requirements including ensuring staff safety through reliable two-way communications.

ALTERNATIVES: Continuing to operate without a vendor-supported radio system introduces significant risk to staff and day-to-day operations. To support ongoing service continuity, TPU requires consistently available communication throughout the remote areas. The current radio system's end-of-life status and lack of vendor support leaves TPU exposed to an extended outage of unknown duration (e.g., hardware failure, software bugs).

COMPETITIVE SOLICITATION:

Request for Proposal, Specification No. PS17-0256F was opened October 2, 2017, Seven companies were invited to bid in addition to normal advertising of the project. Two submittals were received.

Motorola Solutions, Inc. submitted a bid that resulted in the lowest evaluated submittal. The table below reflects the amount of the initial contract term.

Pre-bid Estimate: In 2018 it was \$4,000,000. This did not include the Radio Projects for Cowlitz, Cushman and Nisqually which is now being added to the solution. The recommended award was 134.7 percent above the pre-bid estimate. (The pre-bid estimate covered system hardware and installation costs. It did not include operations and maintenance [O&M] expenses for the expected life of the system which added to the cost.)

CONTRACT HISTORY: This contract was originally awarded to Motorola for Tacoma Power as a result of the above RFP in 2018. Tacoma Rail was added in 2020 to the solution in the amount of \$366,392 for 15 years under a separate new contract form. In 2021, the solution included Tacoma Water under a separate new contract form for 14 years in the amount of \$1,226,508. The solution is now expanded to the remote facilities for 15 years under a separate new contract form.

RECOMMENDATION SUMMARY: Tacoma Power requests approval to increase Contract No. 4600013789, to Stantec Consulting Services Inc. (Stantec), Bellevue, WA, by \$334,000, plus applicable taxes, for additional Phase II, and Phase III and IV Owner's Engineer services for the Alder Unit 11 Rebuild Design-Build Project. This increase will bring the contract to a cumulative total of \$1,506,540, plus applicable taxes.

BACKGROUND:

Tacoma Power contracted the Alder Unit 11 Rebuild Project as Design-Build per RCW 39.10 Alternative Public Works Contracting Procedures. The State's Capital Projects Advisory Review Board's appointed Project Review Committee granted the City approval to use Design-Build contracting for the Project on May 23, 2019, based in part on the experience and expertise of the City's team of in-house staff and consultants. Stantec is a vital member of the City's team.

ISSUE: The purpose of the Alder Unit 11 Rebuild Project is to extend the service life of the machine for an additional 30 years. The last major work on Unit 11 took place in 1989 and the Unit was last rewound in 1973. Tacoma Power needs the experience and expertise of a firm well-versed in hydro turbine-generator rehabilitation to provide Owner's Engineer services during procurement, design, manufacturing, construction and commissioning of this highly technical and complex project. Tacoma Power continues to rely on Stantec's subject matter expertise to review design submittals and perform quality inspection services.

The recommended increase is necessary to retain support from Stantec to cover onsite services during construction and project closeout (Phase III and IV). With this approach, Tacoma Power will continue to benefit from Stantec's subject matter expertise and history with the project.

ALTERNATIVES: The City of Tacoma could rely solely on Tacoma Power engineering staff for the remainder of the Alder Unit 11 Rebuild Project. This alternative poses additional risks to quality and schedule since Tacoma Power engineering staff have limited to no experience with unit rebuilds. Additionally, other projects would need to be deffered to free up staff to perform the work.

COMPETITIVE ANALYSIS: The City's Architectural and Engineering (A&E) roster was used to select the recommended firm, Stantec, based on their qualifications, experience and expertise



with hydro turbine-generator rehabilitation work and Design-Build contracting, and the Department's familiarity with the firm. Stantec's performance to date has been good.

CONTRACT HISTORY: This contract was originally awarded to Stantec as a result of selection from the City's A&E roster and direct negotiations with the firm in March 2019 for Phase I services. The original contract for Phase I services was for a not to exceed amount of \$160,540. The contract was increased by \$398,000 October 2020 to cover added scope to Phase I services and for the anticipated Phase II services. The contract was increased by \$614,000 May 2021 to cover added scope to Phase II services. The requested contract increase will cover remaining services to complete the project.

SUSTAINABILITY: The goal of the Alder Unit 11 Rebuild Project to extend service life of the unit 30 years supports the City's commitment to combat climate change through the generation of green, renewable power.

RECOMMENDATION SUMMARY: Tacoma Rail recommends a contract be awarded to Coast Rail, Inc., Burley, WA, in the amount of \$1,029,991, plus applicable taxes, budgeted from the Tacoma Rail Fund 4500, for approximately 2,400 lineal feet of railroad track, to include three turnouts and other associated track renewals.

STRATEGIC POLICY PRIORITY:

Strengthen and support a safe city with healthy residents.

BACKGROUND:

Tacoma Rail was awarded a WSDOT Zero Interest Loan for railroad track improvements on Tacoma Rail Yard Tracks 7 & 14-17 in the Tideland area, with Tacoma Public Utilities Board acceptance approval September 8, 2021, Resolution U-11280, and subsequent City Council approval September 21, 2021, Resolution 40841.

ISSUE: Periodic replacement of frequently used segments of railroad track are required to enhance safety and mitigate potential service interruptions resulting from deteriorated track conditions. This project will include the removal of heavily worn 112-pound rail and replacement with new 115-pound rail, select crosstie replacement and three new track turnouts.

ALTERNATIVES: There are no practical alternatives. This project is consistent with ongoing incremental infrastructure improvements intended to reduce track maintenance outages necessary to prolong usability lifecycles. The planned project will greatly improve the track structure, safety, and reduce the frequency of future track outages.

COMPETITIVE SOLICITATION:

Request for Bid Specification No. TR22-0184F was opened August 2, 2022. Three companies were invited to bid in addition to normal advertising of the project. Two submittals were received.
