# **RESOLUTION NO. U-11417**

A RESOLUTION related to the purchase of materials, supplies, equipment and the furnishing of services; authorizing the City officials to enter into contracts and, where specified, waive competitive bidding requirements, authorize sale of surplus property, or increase or extend existing agreements.

WHEREAS the City of Tacoma, Department of Public Utilities, requested bids or proposals for the purchase of certain materials, supplies, equipment or the furnishing of certain services, or proposes to purchase off an agreement previously competitively bid and entered into by another governmental entity or a purchasing cooperative, or for the sales of surplus, or desires to increase or extend an existing agreement, all as explained by the attached Exhibit "A," which by this reference is incorporated herein, and

WHEREAS in response thereto, bids or proposals (or prices from another governmental or cooperative agreement) were received, all as evidenced by Exhibit "A," and

WHEREAS the Board of Contracts and Awards or the requesting division have heretofore made their recommendations, which may include waiver of the formal competitive bid process because it was not practicable to follow said process, or because the purchase is from a single source, or there is an emergency that requires such waiver, or because a directly negotiated contract was determined to be in the best interest of the City, or waiver of minor deviations, and in the case of sale of surplus, a declaration of surplus has been made certifying that said items are no longer essential for continued effective utility service, as explained in Exhibit "A," Now, therefore,



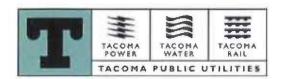

**RECOMMENDATION SUMMARY:** Tacoma Water recommends contracts be awarded to six low bidders for the supply of water treatment chemicals for a contract term of the 2024 calendar year with no option for renewal. The cumulative total for the six contracts is \$2,181,000, plus applicable taxes, budgeted from Tacoma Water Fund 4600.

- Newco Inc dba Cascade Columbia Distribution Co, Seattle, WA for \$284,600
- Univar Solutions USA Inc, Kent, WA for \$823,600
- JCI Jones Chemicals Inc, Tacoma, WA for \$531,000
- Hasa Inc, Saugus, CA for \$112,500
- Chemtrade Chemicals Corp, Parsippany, NJ for \$234,900
- Kemira Water Solutions Inc, East Chicago, IN for \$194,400

#### STRATEGIC POLICY PRIORITY:

- Strengthen and support a safe city with healthy residents.
- Ensure all Tacoma residents are valued and have access to resources to meet their needs.
- Assure outstanding stewardship of the natural and built environment.

The chemicals provided by these contracts are necessary to maintain operations of the Green River Filtration Facility (GRFF) and the water treatment systems at Hood Street Reservoir, which provide clean, reliable drinking water to all Tacoma residents and Tacoma Water customers.

# BACKGROUND:

Contracts are awarded each year for water treatment chemicals, which are delivered in bulk to the GRFF in Ravensdale and Hood Street Reservoir in Tacoma.

ISSUE: Water treatment chemicals provide fluoridation, pH adjustment, and disinfection of the Green River water and South Tacoma groundwater. Chemicals are also required for pretreatment of the Green River supply prior to filtration.

ALTERNATIVES: Water treatment chemicals must be purchased by Tacoma Water or the drinking water supply will not be in compliance with Federal and State drinking water regulations. The current chemicals were selected during facility design as the most



operationally suitable and cost-effective options for Tacoma Water; alternate chemicals cannot be purchased at this time without redesign and construction of treatment facilities.

# COMPETITIVE SOLICITATION:

Request for Bids Specification No. TW23-0229F was opened October 17, 2023. Thirty-five companies were invited to bid in addition to normal advertising of the project. Nine submittals were received.

**RECOMMENDATION SUMMARY:** Tacoma Rail recommends a contract be awarded to Cedar A.I., Seattle, WA, in the amount of \$3,500,000, plus applicable taxes, budgeted from the Tacoma Rail Fund 4500, for an initial contract term of three (3) years with the option for annual renewals, for a projected contract amount of \$3,500,000, plus applicable taxes, for railroad operations & inventory management system.

# STRATEGIC POLICY PRIORITY:

Foster a vibrant and diverse economy with good jobs for all Tacoma residents.

#### BACKGROUND:

Tacoma Rail needs a railroad operations and inventory management system to track railcars, trains, billing information, demurrage, car hire, and communicate with other railroads and entities.

ISSUE: Requirements of a software as a service needed by Tacoma Rail:

- o Generate switch lists, train lists and hazardous materials paperwork
- Track and maintain the railroad's inventory of railcars; dimensions, location, car hire rates, load/empty status, commodity, customer, and other waybill information
- o Track and maintain the railroad's inventory of trains
- o Railroad inventory of track names, alphanumeric number, footages, and types
- Types of railroad tracks include patron and storage tracks
- Railroad inventory of stations
- o Railcar movement history tracking including movement dates/times, types (placement, local movement, constructive placement, release, etc.) and status
- o Automated movement generation based on defined criteria
- Ability to have railcar comments and railcar comment history
- Advanced reporting capabilities

ALTERNATIVES: Wabtec has been the sole source provider of railroad operations and inventory management system software used since 1996, formerly Railcar Management, Inc. The market has expanded to include other software options, so Wabtec is no longer a sole source, prompting the issuance of the RFP.

**COMPETITIVE SOLICITATION:** RFP Specification No. TR23-0122F was opened August 30, 2023. Two companies were invited to bid in addition to normal advertising of the project. Two submittals were received. Submittals were evaluated and scored by a Selection Advisory



Committee (SAC) and below are the resulting scores of the submittals. Both vendors were invited to participate in software demonstrations. Both were held virtually via Microsoft Teams. The SAC then re-scored each vendor, and scores were weighted on each criteria's percentage of total points. After weighting was applied, all scores were calculated, resulting in the ranking of the two vendors.
