RESOLUTION NO. U-11453

A RESOLUTION related to the purchase of materials, supplies, equipment and the furnishing of services; authorizing the City officials to enter into contracts and, where specified, waive competitive bidding requirements, authorize sale of surplus property, or increase or extend existing agreements.

4 WHEREAS the City of Tacoma, Department of Public Utilities, requested 5 bids or proposals for the purchase of certain materials, supplies, equipment or 6 the furnishing of certain services, or proposes to purchase off an agreement 7 previously competitively bid and entered into by another governmental entity or 8 9 a purchasing cooperative, or for the sales of surplus, or desires to increase or 10 extend an existing agreement, all as explained by the attached Exhibit "A," 11 which by this reference is incorporated herein, and 12 WHEREAS in response thereto, bids or proposals (or prices from 13 another governmental or cooperative agreement) were received, all as 14 15 evidenced by Exhibit "A," and 16 WHEREAS the Board of Contracts and Awards or the requesting division 17 have heretofore made their recommendations, which may include waiver of the 18 formal competitive bid process because it was not practicable to follow said 19 process, or because the purchase is from a single source, or there is an 20 21 emergency that requires such waiver, or because a directly negotiated contract 22 was determined to be in the best interest of the City, or waiver of minor 23 deviations, and in the case of sale of surplus, a declaration of surplus has been 24 made certifying that said items are no longer essential for continued effective 25 utility service, as explained in Exhibit "A," Now, therefore, 26

RECOMMENDATION SUMMARY: TPU Power Transmission and Distribution (T&D) Electrical Services recommends a contract be awarded to Northwest Cascade, Inc., Puyallup, WA, in the amount of \$1,043,677.00, plus a 15 percent contingency, for a cumulative total of \$1,200,228.55, plus applicable taxes, budgeted from the Tacoma Power Fund, for electrical utility vault and duct bank installation as well as applicable street restoration within City Right of Way.

STRATEGIC POLICY PRIORITY:

- Strengthen and support a safe city with healthy residents.
- Ensure all Tacoma residents are valued and have access to resources to meet their needs.
- Assure outstanding stewardship of the natural and built environment.

BACKGROUND:

The project will improve the electrical utility infrastructure by installing utility vaults and connecting duct banks that will meet the electrical demands of the existing and future development in this area of downtown. Existing impacted sidewalks will be replaced and widened, and impacted alley way entrances will be replaced with bulbed out entrances.

Work for this project is located between Court D and Court E along S. 17th St. and integrates with work which was completed in 2022 on Fawcett between S. 17th and S. 21st. All of this work is part of a larger project to build a new underground system into Downtown Tacoma from Nisqually Substation. This overall project is necessary due to the limited additional ampacity available in the existing system and the age of the existing system, the majority of which is ~90 years old.

ISSUE: Electrical demands within the developing downtown area of Tacoma have increased through the years. The project's work includes electrical infrastructure upgrades that are essential to meet the electric demands of the existing and planned developments within the Downtown and Hilltop neighborhoods.



ALTERNATIVES: The alternative is to not install the electrical infrastructure. Doing so could result in an overloading of the the existing power infrastructure, resulting in unforeseen failures and power outages, particularly during high power consumptions periods.

COMPETITIVE SOLICITATION: Request For Bids Specification No. PW23-0090F was opened March 19th, 2024. There were 136 companies invited to bid in addition to normal advertising of the project. Three submittals were received.

Northwest Cascade, Inc. submitted a bid that resulted in the lowest evaluated submittal after consideration of EIC participation goals. The table below reflects the amount of the base award.

Pre-bid Estimate: \$823,260.00 The recommended award is 27 percent above the pre-bid estimate.

CONTRACT HISTORY: New Contract

SUSTAINABILITY: This solicitation was done as a Request for Bids, where Sustainability is not considered in the award. However, TPU engineers worked with the Public Works Department to ensure this project was done in compliance with the City of Tacoma's current Public Works Sustainability requirements for new projects. In addition, street trees will be planted per City codes pertaining to new sidewalks.

EQUITY IN CONTRACTING (EIC) COMPLIANCE: The recommended contractor is in compliance with the EIC requirements per memorandum dated March 25, 2024. The EIC requirements for this project are eight percent MBE, two percent WBE, and eight percent SBE. The EIC utilization levels of the recommended contractor, Northwest Cascade, Inc., are 8.05 percent MBE, 2.54 percent WBE, and 8.06 percent SBE.

LOCAL EMPLOYMENT AND APPRENTICESHIP TRAINING PROGRAM (LEAP) COMPLIANCE: The LEAP requirement for this project is 15 percent of the project labor hours must be worked by Local Employees, per TMC 1.90.040.

RECOMMENDATION SUMMARY:

Tacoma Power, Utility Technology Services requests approval to increase contract CW2251179, to GridBright, Inc. (GridBright), Alamo, CA, by \$150,000, plus applicable taxes, budgeted from the 4700 Power Fund, for continued Trusted Advisor services throughout the ADMS implementation. This increase will bring the contract to a cumulative total of \$650,000, plus applicable taxes.

BACKGROUND:


TPU sought a trusted advisor to provide insight into the growing ADMS space, conducting an organizational needs assessment, guidance toward maximizing positive business and project outcomes, leading the development of initial requirements and preparation for the ADMS project procurement phase and the development of a TPU ADMS-based strategy and roadmap. TPU sought outside council due to TPU's limited knowledge and experience in the ADMS workspace.

ISSUE: The ADMS RFP is now in its final stages of award and contract negotiation. Engaging the services of GridBright has been crucial to ensuring the successful award, negotiation, contracting, and implementation of the ADMS supplier. Their extensive domain expertise and experience in utility system integration projects will be an invaluable resource.

Furthermore, GridBright's consultation will greatly benefit TPU in the development of the ADMS Systems Integrator RFP. Their profound knowledge of industry best practices will help TPU craft a comprehensive and robust RFP, mitigating potential risks and ensuring a seamless integration of the ADMS with existing systems and processes.

The rapidly evolving technological landscape and increasing complexity of modern distribution management systems necessitate the engagement of seasoned consultants like GridBright. Their specialization in this domain will enable TPU to navigate the implementation processes with confidence, ensuring a future-proof solution that aligns with TPU's long-term strategic objectives and operational requirements.

ALTERNATIVES: One alternative is to not extend GridBright's current contract. Not extending GridBright's contract could have severe negative impacts on the successful ADMS implementation at TPU:



- 1. Loss of critical subject matter expertise and industry knowledge.
- 2. Incomplete requirements gathering for the ADMS Systems Integrator RFP.
- 3. Potential selection of a suboptimal ADMS vendor without GridBright's guidance.
- 4. Increased project risks due to lack of experienced oversight during integration.
- 5. Disruption of continuity and knowledge transfer between project phases.

Given the complexity of the ADMS project, discontinuing GridBright's services exposes TPU to significant risks that could jeopardize timelines, budgets, and the overall success of the implementation. Their specialized expertise is invaluable for ensuring a seamless integration aligned with TPU's operational needs.

COMPETITIVE SOLICITATION:

Request for Proposal Specification No. PT22-0127F was opened Tuesday April 22, 2022. Two hundred and thirteen companies were invited to bid in addition to normal advertising of the project. Nine submittals were received.

GridBright, Inc. submitted a bid that resulted in the highest evaluated submittal. The table below reflects the score of the base award.

Pre-bid Estimate: \$500,000

The recommended award was exactly the pre-bid estimate.

CONTRACT HISTORY: This contract was originally awarded to GridBright, Inc. as a result of RFP Specification No. PT22-0127F in April 2022 in the amount of \$500,000. GridBright then entered into a Master Business and Services Agreement along with executing a Scope of Work (SOW) for Trusted Advisor services. The SOW is scheduled to expire September 1, 2024. The Master Agreement is perpetual until terminated by either party upon 60 days written notice.

Amendment No. 1 seeks to add additional funding in the amount of \$150,000 to support the ADMS program as it moves forward through contract negotiations, Systems Integration RFP work, and project start-up and design activities.



RECOMMENDATION SUMMARY: Tacoma Power requests approval to increase and extend Contract No. 4600013776, to Iljin Electric USA, Inc., Houston, TX, by \$5,000,000, plus applicable taxes, budgeted from the Tacoma Power Capital Budget, for power transformers. This increase will bring the contract to a cumulative total of \$10,000,000, plus applicable taxes. Tacoma Power further requests approval for a three-year extension of contract term. This extension will bring the contract to a cumulative term of eight years.

BACKGROUND: Procurement of substation transformers is critical for the continued replacement of assets that are nearing the end of service life, and for the installation of new substations. The three-year extension of contract duration and \$5,000,000 increase in contract value with Iljin Electric USA, Inc. is the most cost-effective means of providing a supply chain for substation transformers.


ISSUE: Tacoma Power anticipates replacing four transformers during the extended contract term. Current lead times for transformers are approximately 30 months from time of order.

ALTERNATIVES: As an alternative to a contract extension and increase, Tacoma Power could seek a new contract through a competitive solicitation process. A recent Request for Bids, that was ultimately rejected, demonstrated that costs and lead times from other potential transformer suppliers were less beneficial to the City.

CONTRACT HISTORY: This contract was originally awarded to Iljin Electric USA, Inc. as a result of Request for Bids Specification No. PT18-0329F in March 2019. Tacoma Public Utility Board approval was February 27, 2019, U-11059. A one-year extension was executed in March 2022 and a one-year extension was executed in March 2023. A contract increase of \$1,823,000 was executed in April 2023.

SUSTAINABILITY: Sustainability factors were not considered in this contract extension and increase.
