### Take advantage of our community's Pipeline Trail for outdoor recreation

The City of Tacoma completed the third and final phase of the Pipeline Trail. It stretches 1.4 miles along East 56th Street, East 72nd Street, and Waller Road East. The project was a long collaboration between the City, Pierce County, and Tacoma Water, and the entire trail is now available for use.

The new segment is part of a larger 4.3-mile trail throughout the city. It is ADA accessible with a 12-foot-wide asphalt surface, LED lighting, signage, and benches. Most of the Pipeline Trail runs above the underground water pipeline the trail is named after. It provides many recreational opportunities that support healthy, active living in our community. This utility corridor connects the trail to neighborhoods and communities and is the perfect route for everyone to enjoy due to its linear nature.

#### manage utility bill payments and balances

- Suspension of disconnections for nonpayment.

### SUMMER WATER RATES ARE IN EFFECT

Summer water rates went into effect on June 1. We charge a slightly higher rate for water use above five units (about 3,700 gallons) from June 1 through Sept. 30, when it can cost more to provide water during the drier, summer months. The two rate levels help encourage everyone to use water wisely to ensure enough water is available for our community, fish, and other wildlife. You can reduce water use outdoors and indoors and save money on your water bills with a few simple tips.

## How you can accelerate local renewable energy projects

Local non-profits and schools can now apply for a renewable energy project grant of up to \$50,000.

#### How to use water wisely even in abundance

Even with other areas of the West coast experiencing an early drought this year, we don't anticipate any water supply issues in our region. Our experts regularly analyze snowpack in the Green River Basin, the water level in our reservoir, how much rainfall we receive, and how much water the communities we serve use. Based on current conditions and Forecasts, we anticipate we will have a sufficient water supply for people and fish this summer.

During the warm summer months water use can increase significantly outdoors, so we ask that you use water wisely. Many of the most effective things you can do to save water, reduce your bill, and protect our water supply are simple and easy:

## Tax credit available for past and future home energy upgrades

We have good news if you've upgraded your home with energy-efficient products in the past or you plan to this year. On top of the rebate or loan that we provide, the IRS would like to thank you in the form of a tax credit. Projects completed from 2018 through the end of 2021 could get you a tax credit of up to \$300. Upgrades that qualify for the tax credit include heating and cooling systems, hybrid water heaters, insulation, windows, and more. Make a note so you remember to submit your project documents with IRS Form 5695 when you file your 2021 taxes in 2022.

# Employees modify fundraisers and exceed giving back in new ways

Our employees have a strong history of giving back to the communities we serve. Over the past year, they got creative adapting fundraisers through our employee giving and volunteer program, Community Connection, during the pandemic. COVID-19 couldn't dampen their long-standing tradition of giving – not even a little.

In January, employees and their families donated 1,477 pounds of food and basic needs items to benefit Nourish Pierce County Food Banks through our **Winter Food and Basic Needs Drive**. We beat our 2020 weight by 500 pounds!

This year our **Delectable Desserts** team partnered with external organizations for the first time: Lutheran Community Services Northwest and Love by the Slice Bakery Catering to deliver over 150 Valentine's Day cupcakes to some Tacoma seniors and raised over \$4,900 for the TPU Senior Assistance Fund – a \$2,613 increase over last year! Employees' donations covered the cost of the cupcakes and the contributions to the fund. The cupcakes they bought also supported a local Black-owned business.

Our annual **Boys & Girls Clubs of South Puget Sound Bowl-a-thon** received a makeover into the first-ever photo scavenger hunt supporting the Boys & Girls Clubs. Employees raised \$9,360, and 128 participated. U\*
