Dear Secretary:

Settlement Agreement License Article 22 of the above referenced license requires that "Within one year of license issuance, the Licensee shall file with the Commission a report, prepared in consultation with the Forest Service, documenting Licensee's efforts to negotiate the transfer of Forest Service and other lands for the purpose of consolidating land ownership within the Cowlitz River Project area." By letter dated September 26, 2003, FERC established July 18, 2003, as both the effective and issuance date of the license. This letter and the attached letters comprise the report. Enclosed are eight copies of this letter/report and attachments.

Discussions with the Gifford Pinchot National Forest (GPNF) staff and the staff of the Pacific Northwest Region of U.S Department of Agriculture - Forest Service started in 1999. At that time, GPNF staff and Tacoma Power met to discuss a land exchange or purchase. Little additional action occurred until March 2, 2001 when Tacoma Power sent a letter to GPNF renewing the proposal made in 1999 and asking for approval. The reply on April 5, 2001 by the Regional Forester, Pacific Northwest Region, indicated willingness to work with Tacoma Power to explore the idea of a land exchange. A meeting was conducted on June 12, 2001. Tacoma Power sent a further letter on June 18, 2001 to GPNF. GPNF reviewed Tacoma Power's proposal and declined to give up ownership of their parcel of land within the project area in a letter date October 5, 2001. Copies of the offer letters and the replies from GPNF are attached.

On June 4, 2004, Tacoma Power again queried GPNF to see if their position on a land exchange had changed (see attached letter from Debbie Young to Claire Lavendel). This letter also reiterated that Tacoma Power felt that "pursuing purchase or exchange of this property is in the best interest of both of our agencies." Lynn Burditt, Acting Forest Supervisor, GPNF responded in a letter dated June 15, 2004 that the position of GPNF had not changed and stated their reasons. This letter is attached. Tacoma Power will continue to check with GPNF in the future to ascertain if their position on disposing of this parcel has changed. July 16, 2004 Page 2

Dear Ms. Lavendel:

In a letter dated June 18, 2001, I wrote to you to express Tacoma Power's interest in purchasing or exchanging up to 5.1 acres of United States Forest Service (Forest Service) Gifford Pinchot National Forest lands within the Cowlitz River Project boundary. In your reply letter dated October 5, 2001, you stated that the Forest Service wanted to retain ownership of the parcel in question. I have attached copies of past correspondence for your convenience. Since that time, Federal Energy Regulatory Commission (FERC) issued the license for the Cowlitz River Hydroelectric Project by issuing an "Order Denying Rehearing and Lifting Stay" on July 18, 2003.

Article 22 of Appendix A of the above mentioned license states:

"Within one year of license issuance, the Licensee shall file with the Commission a report, prepared in consultation with the Forest Service, documenting Licensee's efforts to negotiate the transfer of Forest Service and other lands for the purpose of consolidating land ownership within the Cowlitz River Project area. The Commission reserves the right to require additional reports on the progress of such negotiations should they not be concluded within one year of license issuance".

Since a discussion had taken place with your agency prior to license issuance as noted above, Tacoma Power is writing to confirm your previously stated position in order to comply with this license requirement. During a telephone call between Tom Martin and John Roland, John indicated that the Forest Service position on this matter has not changed. Therefore, I am requesting that you confirm, in writing, your previously stated position. This letter, along with the preceding letters, will be submitted to FERC as part of our report on this license article. This is in response to your June 18, 2001, letter. I apologize for the delay in responding; however, it took time to meet with the necessary staff for input into your proposal of conveying the Federal parcel within the Cowlitz River Hydroelectric Project.

On September 26, we held a telephone conference with our Regional FERC Coordinator, Walt Dortch, and various members of my staff. Walt explained that the Forest Service position is to consider standard issues, such as public interest, isolation of tracts of public land, identifying the management objectives, and analysis of the economics of retaining or conveying National Forest land.

After discussing the proposal of conveying the  $3\pm$  acres of Gifford Pinchot National Forest lands within the Cowlitz River Hydroelectric project, it was recommended that the Forest Service retain ownership of this parcel for the following reasons:

- 1. The parcel is contiguous to National Forest land.
- 2. Cost to manage this parcel is no higher than other National Forest land.
- 3. It appears to be in the public interest to retain this parcel in public ownership.
- 4. The authority to convey this parcel would be through a land exchange, which is time consuming and costly to process. Such a project could not be considered in the program of work within the next two to three years.
- 5. There is interest in retaining our "4e" authority in this FERC project.

Our resources are so limited that it is now difficult to evaluate new projects. Therefore, I cannot provide further consideration to this proposal at this time.

In a letter dated March 2, 2001, I wrote to express Tacoma Power's interest in purchasing or exchanging up to 32.5 acres of Gifford Pinchot and Olympic National Forest lands within the boundaries of the Cowitz, Cushman and Nisqually Hydroelectric Projects (FERC Nos. 2016, 460, and 1862, respectively). On April 5, 2001, you replied, directing me to contact Bill Bliesner of your staff. On June 12, 2001, my staff and I met with Mr. Bliesner and others of your staff to discuss the proposed transaction.

Because some of the parcels included in the proposed transactions at Tacoma's Nisqually and Cushman Projects exceed the 10-acre threshold for transactions under the Small Tracts Act, these transactions have been temporarily put on hold. Your staff indicated it is likely the 10-acre threshold will soon be revised to 40 acres. Mr. Bliesner will keep us informed of the progress of this revision. In the meantime, Mr. Bliesner is consulting with your Office of General Counsel to get an opinion on whether the Forest Service is prohibited from exchanging its lands for other lands of comparable size but of greater value. He will get back to me soon with a legal opinion. The purchase or exchange proposed for lands at Tacoma's Cowlitz Project is proceeding separately.

In a letter dated August 18, 1999, I wrote to express Tacoma Power's interest in purchasing or exchanging up to 5.1 acres of Gifford Pinchot National Forest lands within the Cowitz River Hydroelectric Project boundary (FERC No. 2016). On September 16, 1999, Toby Freeman and Ted Lyons of Tacoma met with Vicky Wessling of your staff to discuss this transaction. Although no further action has taken place until recently, our shared intent to complete this transaction was captured in proposed License Article 22 in Appendix A of the Cowitz River Hydroelectric Project Settlement Agreement (August 2000).

The ratepayers of Tacoma Power own and operate the Cowlitz River Hydroelectric Project with the intent of providing reliable and reasonably priced electricity essential to the economic well-being of the modern communities it represents. In addition, the Project provides a diverse range of opportunities to the recreating public. Because hydroelectric project boundaries are established under the Federal Power Act, the lands in questions are not only *suitable* for meeting the community purposes provided by a hydroelectric project, the lands are *required* to be used for project purposes, regardless of ownership.

Should ownership of the lands in question be transferred to Tacoma Power they will remain undeveloped within the Project boundaries and managed by the Washington Department of Fish and Wildlife as part of the Cowlitz Wildlife Area. Thus, no risk of resource damage or sanitary or public health problems will arise as a result of a land purchase or exchange.

As a small isolated tract, the lands in question are of little or no value for virtually any multiple-use activity authorized by the Forest Service. The lands are not "necessary for more important federal purposes," as their size and location within the Project boundary will exclude them from ongoing Forest Service multiple use programs. In addition, Section 24 of the Federal Power Act, 16 U.S.C. 818, restricts the use of federal land occupied by hydroelectric projects to power development purposes, further narrowing the opportunity for other uses. The purchase of these lands by Tacoma Power would relieve the Forest Service of the need to expend resources managing this small parcel.

#### Page 2

The purchase of the lands could be accomplished under either the Townsite Act or the Small Tracts Act. Our proposal for an exchange includes first making a revision to the Cowlitz River Hydroelectric Project boundary to exclude as much Forest Service land as possible, then simply exchanging the remaining 3.0 acres of Gifford Pinchot National Forest land within the revised Project boundary for other nearby lands that would be excluded from the Project boundary. This proposal was described and shown in handouts provided to Vicky Wessling of your staff at a meeting on June 12, 2001. The parcel proposed for exchange is timbered land, and adjacent to existing Forest Service ownership. As such it would represent an increased value to the Forest Service. Tacoma also would be willing to purchase the 3.0 acres within the Project boundary.

We look forward to proceeding with a sale or exchange, and I eagerly anticipate your call to me at (253) 502-8340 so that we may discuss the next steps to be taken.

Dear Ms. Young:

Thank you for your letter concerning a proposal to exchange land between the Forest Service and the City of Tacoma/Tacoma Power (Tacoma). The proposal involves National Forest lands at Lake Cushman on the Olympic National Forest at Alder Lake on the Snoqualmie National Forest (which are managed by the Gifford Pinchot National Forest), and Riffe Lake on the Gifford Pinchot National Forest. These lands have been under Federal license to Tacoma for hydroelectric projects.

The Forest Service lands in the project areas have been inundated by the project reservoirs and now have little or no value for use and management as part of the National Forests. Since they have lost their character as part of the National Forest, it may be appropriate that they be conveyed out of Forest Service ownership. Past discussions on these lands have been positive and we believe that it may be in the public interest for the Forest Service to convey these parcels to Tacoma through a land exchange or sale. The Forest Service has authority to exchange the lands under the General Exchange Act of 1922 and the Federal Land Policy and Management Act of 1976, as amended. The land could also be sold or exchanged under the Forest Service Small Tracts Act of 1983.

Although previous discussions were positive, they did not result in any action being taken. This, we believe, was due to both the Forest Service and Tacoma having other higher priorities. You indicate that Tacoma has now completed its re-licensing applications on these projects, and that it would be a good time to pursue the exchange proposal. From the Forest Service standpoint, we are still involved in higher priority work and also may not be able to commit the staff and funding needed to work on the proposal at this time. We are, however, willing to further discuss the proposal. You should keep in mind that the Forest Service exchange process has many required steps, such as appraisal, public notices, and compliance with the National Environmental Policy Act (NEPA), and various other laws. It can be an expensive and time-consuming process and Tacoma would be expected to share in the costs of completing the exchange.

We have contacted the Lands staffs on the Olympic and Gifford Pinchot National Forests and asked them review your proposal. We would like to further discuss the proposal with you and provide additional details concerning the steps in the process and schedules. As you suggest, a meeting may be a good way to begin the process again and to address any questions and concerns. ### Subject: Land Exchange Between the U.S. Forest Service and City of Tacoma

The City of Tacoma, Department of Public Utilities, Light Division (dbaTacoma Power) recently filed an application for renewal of the federal license for its hydroelectric project on the Cowlitz River. This is the last of Tacoma Power's federal license applications, with the Nisqually and Cushman Projects recently receiving their new licenses. When the hydroelectric projects were originally constructed, Tacoma Power made a significant effort to assure that title was held to all effected lands, though a few small parcels of U.S. Forest Service land were inundated at each site, totaling about 32.5 acres. This was not a significant problem at the time, but the current licensing procedures make these unresolved land issues burdensome for both Tacoma Power and the Forest Service. Beyond the effort required for licensing, the Forest Service also has an ongoing responsibility for managing inundated lands within Tacoma Power's project boundaries that are of no value to the Forest Service.

With these license applications behind us, it would seem that this is an excellent opportunity to clear up our boundaries through a land exchange that would benefit both Tacoma Power and the Forest Service. Based on previous discussions with local Forest Service staff, Tacoma Power has developed the following proposal. Tacoma Power offers 31.5 acres of forest land in two parcels contiguous to Forest Service lands at the Cushman and Cowlitz Projects, in exchange for 32.5 acres of inundated lands at the Nisqually, Cushman and Cowlitz Projects. Detailed legal descriptions and maps are attached for your review.

Our early discussion on this matter was positive and constructive, but neither party was able to complete the process, due partially to complications with the project licensing process. With the licensing now completed, this would be an excellent time to finish what we have begun. To this point, the Forest Service has shown support for this exchange and Tacoma Power's intent on proceeding. As a first step in this renewed effort, please provide us with a letter describing the steps to be taken, a schedule for this process, and an affirmation of the support from the Forest Service. A meeting may help to answer any questions. We will call you to see if one can be arranged. Thank you for your support and efforts in this matter.

The City of Tacoma, Department of Public Utilities, Light Division (dba Tacoma Power) is the owner and licensee of the Cowitz River Hydroelectric Project (FERC No. 2016) located in Lewis County, Washington. Tacoma Power is in the process of extensive consultation in preparation for filing an application with the Federal Energy Regulatory Commission for a new license, as the current license expires December 31, 2001.

The purpose of this letter is to request that representatives of the U. S. Forest Service and Tacoma Power meet to discuss the possibility of exchanging or selling approximately four acres of Gifford Pinchot National Forest land located within the Project boundary, as required under the Federal Power Act. It would be most helpful to convene an initial meeting within the next 14 days.

Tacoma Power understands that a transfer of this land will involve a review of Forest Service rules covering small tracts, the Township Act, or other regulations applying to such transactions. We would like to discuss all options that may be available to implement a sale or exchange, and the reasons why Tacoma Power believes such a transaction would be in the public's interest.
