# Planning an activity that disturbs the soil? Help protect cultural resources by contacting Tacoma Power

Everyone plays a part in protecting our shared heritage along the Skokomish River. If you're planning an activity on Tacoma Power property that disturbs the soil, Tacoma Power needs to know. In addition to permission from Tacoma

Power, your plan may require review so that it doesn't impact a cultural/archeological site. These evaluations are a necessary part of following federal and state laws that protect cultural resources.

Dylan Henderson, Tacoma Power's cultural resources coordinator, works with a professional archaeologist to protect cultural resources in the area of Lake Cushman, Lake Kokanee, and Cushman dams and hydroelectric facilities.

This effort involves evaluating ground disturbing activities and other actions that may impact cultural sites, whether the activities are undertaken by Tacoma Power staff, Cushman residents or visitors. Mr. Henderson also consults with the Skokomish Indian Tribe to protect cultural resources linked to tribal ancestors and traditional lands.

### Are you planning any of these activities?

- Digging, excavating, or grading
- Construction or maintenance of a dock, bulkhead or other reservoir structure
- Installing posts or earth anchors
- Dragging heavy logs or equipment
- Planting or pulling vegetation

# Be a good neighbor by helping preserve cultural resources:

- Obey posted signs and do not enter gated areas. Off-road vehicle travel is not permitted.
- Do not disturb any artifacts, human remains or other cultural items. Immediately report such finds to Tacoma Power's Lands Officer at (253) 502-8824.
